ARTICLE VI: ELECTION

Section 1

All life members and annual members of OSA have the right to vote and participate in the election.

Section 2

All elections are to be conducted by a secret ballot. The election procedures shall be described in the By-Laws.

Section 3

No two members of the Executive Committee at any time shall be from the same immediate family (e.g. Husband & wife, parents & children, siblings) of any Executive Committee member.

Section 4

In case, a current office bearer such as, President, Vice President, or Secretary-Treasurer, decides to run for re-election or for another position, he/she shall give up all his/her election related responsibilities as defined in the By-Laws.

BY - LAW III: ELECTION PROCEDURE

Section 1

A three member election committee with one as chairman shall be appointed by the Executive Committee and will be announced to the general body for approval by majority at the annual convention preceding the election year.

Section 2

No member of the Executive Committee is eligible to be a member of the election committee.

Section 3

The Secretary of the OSA shall prepare a list of members who have paid their dues by Dec. 31 of the year preceding the election year. This list along with the list of life members and patrons shall be submitted to the chairman of the election committee by Jan. 15 of the election year.

Section 4

Nominations for the various offices shall be invited by the election committee chairman through the OSA newsletter of September-December quarter, preceding the election year. In case of contests, the names of the candidates shall be announced in a special letter to be sent by the election committee along with the position statement of each contesting candidate.

Section 5

The Secretary of the OSA shall print and supply the ballots to the election committee. All ballots must be sequentially numbered or coded.

Section 6

The ballots shall be mailed in the fourth weekend of March of the election year. The ballot number or code must be noted against the master membership list held by the election committee. For a returned ballot to be valid, it must be postmarked by the date on or before the 4th Monday of April of the election year.

Section 7

The election committee shall open a post office box address to which the ballots shall be mailed to by the voters. The ballots shall be counted in the presence of the election committee members and the candidates or their representatives on the second Saturday of May of the election year. The results of the election shall be announced then and there with a written statement of the results sent to the President of the OSA. All the election materials must be sealed and signed by the election committee members and the candidates or their representatives, and will be preserved by the election committee chairman for a period of six months after the election.

Section 8

The President of OSA shall submit the results to the Executive Committee for approval and for a publication in a special Newsletter by May 30th of the election year.

Section 9

The election committee shall adopt prudent ways to insure the secrecy of the voting system.

Section 10

All expenses for the election shall be reimbursed by the Secretary-Treasurer of OSA upon the submission of the expense report. The committee shall caution to keep expense within the budget.

Section 11

Any charge of election irregularity or fraud shall be reported to the President and the members of the Executive Committee for resolution.

Section 1: General Guidelines

- If no suitable candidate is found in a particular year for a particular category, no award may be given.
- In the event of a tie, or if the awards committee felt that more than one person deserve the award, the number of awards may be increased to two in any given year.
- The nominator of an award must be a *member of OSA* at the time of nomination. The nomination process is different for different awards.
- Self-nominations will not be accepted.
- The contact information of the referees (telephone no., email address etc.) for various award categories must be provided in the nomination form to enable the judging committee to contact them. Only referees who are prepared to provide verbal or written recommendations should be included.
- With the exception of Subrina Biswal award, no member of the national executive and award committee including family members may be nominated for any award to maintain transparency of the award process.
- One person may not be nominated for more than one award category.

Process of Selection:

- A three-member selection committee appointed by the OSA President on behalf of the Executive Council for each award will select the recipient for the award.
- The decision of the awards committee is final.
- A biographical sketch outlining the life and legacy of the recipient of the award will be featured in next issue of the OSA Journal.

Time Line:

- Last date for nomination: April 15 (post-marked/ electronic).
- Judging will take place: between May 1 and June 10.
- Announcement of result: June 15.
- Award presentation will be made during the OSA Convention.

Section 2: Award Details

1. DISTINGUISHED ORIYA AWARD:

The Distinguished Oriya award is the highest award presented by the Orissa Society of the Americas, a non-profit organization operating in North America to preserve and promote the culture, heritage, and customs of Oriya speaking people.

Recipients will receive an inscribed plaque and a certificate of honor at a special function or in the annual Convention hosted by the OSA.

Criteria for Recognition:

Selection is based on contribution in one or more of the following areas:

The nominee must have

- Proficiency in professional disciplines with outstanding accomplishments in arts, theatre, literature, science, technology, medicine and /or similar fields.
- Rendered public service with innovative application of resources to enhance literacy, health, education, hygiene, child care, community service and similar other humanitarian and philanthropic service with direct contribution to Orissa, the land and its people.
- Proficiency in and outstanding contribution to Oriya Art, Culture, Heritage and Literature.
- Leadership to bring forth social justice in Orissa.
- Entrepreneurial skills to cultivate resources in order to provide economic stimuli and opportunities for employment and economic growth in Orissa.
- Patriotic idealism to uphold the honor and dignity of Oriya people.
- Acts of heroism directly contributing to the cause of Orissa and its people.

Eligibility Requirements:

The nominee must be a member of the OSA with good standing or have, in case of nominees from overseas, must have contributed to the OSA in a tangible and visible manner. The nominator must be a member of the OSA with good standing.

Nomination Process:

Names of three referees, preferably OSA members and having good knowledge of the nominee and his / her field of expertise or achievement, who would agree to provide written or verbal reference on the merits of the nominee must be included in the application. Self-nominations will not be accepted.

2. KALASHREE AWARD

The Kalashree Award is an honor in recognition of an individual's continued service to Oriya art, literature, music, dance, and similar cultural and heritage-based activities in North America. *The Award will be presented in form a plaque in a special OSA meeting or in the Annual convention.*

Criteria for Selection:

Selection will be based on contributions in one or more of the following areas:

The nominee:

- As a promoter of Oriya art and culture, must have outstanding record of cultural activities such as promotion of Oriya language and literature, hosting of events featuring Oriya cultural programs including visiting artists.
- As a performing artist, must have demonstrated high quality artistic productions, training, and choreography in areas such as Odissi Dance, Odissi Music, Folk dance and music of Orissa, and similar other traditional art of Orissa including production of Oriya films, Oriya dramas, (and, if in any other language, must feature Oriya culture and heritage), hosting of conventions promoting Oriya artists and artistic endeavors.
- As an established author, must have demonstrated high quality authorship in areas such as novels, stories, poetry and such other literary activities in Oriya. Only activities and/ or accomplishments performed in North America will constitute grounds for consideration.

Eligibility Requirements:

- The nominee must be an OSA Member at the time of nomination.
- The person should have several years of active participation in cultural activities of the OSA.

• The person must be, during the year of the Award, living in North America.

Nomination Process:

An individual member of the OSA with good standing may nominate a candidate in the approved nomination form. It will be required to name three referees who must be members of the OSA and have good knowledge of the cultural activities of OSA. One of the referees must be from the Chapter to which the nominee belongs, so that he/she can report on the role of the individual in the Chapter's cultural and literary activities. *Self-nomination will not be accepted*.

3. UTKALAMANI GOPABANDHU DAS MEMORIAL AWARD

The Award is presented to an individual in recognition of his/ her outstanding contribution to Orissa in areas of humanitarian and community service. The recipient demonstrates a role model to the Non-resident Oriya community for his / her philanthropic accomplishments, dedication and selfless service to humanity. The Award in form a plaque with appropriate citation and picture of Utkalamani Gopabandhu Das will be presented to the recipient in a special function of the OSA or during the Annual Convention.

Criteria for Selection:

The nominee must have made outstanding contribution to the land and people of Orissa in areas such as, but not limited to,

- Social work
- Addressing and resolving women's issues and rehabilitation
- Improving economic well-being of disadvantaged persons
- Relief operation
- Community service, community health
- Relief of poverty
- Advancement of education at various levels and in various sectors
- Advancement in services in the Health Sector

and similar other philanthropic endeavors in Orissa.

Eligibility Requirements:

Must be a member of the OSA with good standing.

Nomination Process:

Nominator must be member of the OSA with good standing and must fill out the nomination form with names of three referees who should comment on the nominee's accomplishments. The referees must be members of the OSA or have good knowledge of the kinds of service done in Orissa by NROs. *Self-nomination will not be accepted*.

(4) SUBRINA BISWAL AWARD FOR HIGH SCHOOL GRADUATES

Every year, the Orissa Society of the Americas, in joint sponsorship with Dr. Nilambar and Annapurna Biswal and Dr. Sitakantha Dash, presents the Subrina Biswal Memorial award to honor an outstanding high school graduate from OSA member families. Recipients are selected based on their academic achievements, extra-curricular activities, interest in the arts, and personal qualities. This award, initiated in 1990 by Dr. Nilambar and Annapurna Biswal of Maryland in the loving memory of their daughter, Subrina, provides the recipient with one-time scholarship of US \$1000.00.

Eligibility Requirements:

- The applicant must be the son/daughter of an OSA Member with good standing.
- The applicant must be a graduating high school senior from any School in the USA or Canada.

Criteria for Selection:

Assessment will be made on all of the following criteria:

- Academic achievements.
- Extra-curricular activities
- Interest in arts
- Personal qualities demonstrated by career goal and objectives in life

Submission Requirements:

- High School transcripts
- Two letters of recommendation including one from a teacher of the school attended.
- A bio-data identifying all of the four points under criteria
- A short essay by the applicant highlighting career goal and objectives in life.

5. YOUTH VOLUNTEER AWARD

Award to recognize a youth (16-40 years of age) for community service in North America, Orissa, for service to OSA or Chapter, organizational leadership, volunteer work, capacity building etc. Presentation of these awards will generate interest in other youth to participate in community events. A plaque and a certificate will be presented in a special OSA function or in the Annual OSA convention.

Eligibility Requirements:

- Must be between 16 to 40 years of age
- Must be an OSA member or belong to an OSA member family.
- Must be resident in North America

Nomination Process:

Nominator must be a member of OSA. Approved nomination form filled out with names of three referees one of whom may belong the Chapter to which the youth belongs.

6. YUVA KALA VIKASHA AWARD:

Award to recognize a youth for outstanding contribution in promotion of Oriya culture, literature, arts, music, dance etc in North America. Presentation of these awards will generate interest in other youth to participate in Oriya culture and OSA events.

A plaque and certificate to be presented in a special OSA function or in the Annual OSA convention

Eligibility Requirements:

- Must be a High School student/ graduating High School student.
- Must belong to an OSA member family.
- Must be resident in North America.

Nomination Process:

Nominator must be a member of OSA. Approved nomination form filled out with names of three referees one of whom, in so far as possible, may belong to the Chapter to which the youth belongs.
