1	Introduction	Newly elected President Mr Tapan Padhi welcomed everyone to the meeting. All BOG members briefly introduced themselves.	
2	OSA 2014 Convention Update		
3	Discussion on various committee formations	Grievance Committee: President informed the BOG about the formation of the grievance committee during Chicago OSA convention consisting of three members. They are Surya Mishra, Kuku Das and Panchanan Satpathy. It was accepted unanimously. Proposal for forming Senior Citizen Committee, Social Committee, Cultural Committee, Organizational Committee and Youth Committee came from the President and he asked the members to come up with names for the next meetings to be discussed in detail. He announced that Mr Niraj Rath has become General Counsel.	
4	Timing for future BOG meetings.	It was unanimously decided that meetings will be conducted at 7.30 P.M. EST on the 2 <sup>nd</sup> Sunday of every month.	
5	Recent demises	Tapan Padhi talked about recent unfortunate demises. He asked members to provide suggestions of ways OSA can help in this type of situation. Various suggestions were given and discussed. One suggestion was that OSA connects all Odias in North America through a network of volunteers by building a help line. Other suggestions were that OSA should come up with a policy that defines various help OSA can provide on humanitarian and health awareness aspects and OSA to look into group insurance policy for members.
