Item	Торіс	Conclusions/Discussions
1	Adopt-A- Village OSA Service Project (Proposal)	A proposal to start a night school for men and women and skill training for women of the Badigaan Village under Paralakhemundi district was sent to BOG. Annapurna Pandey provided the current situation of this tribal village and economic and social condition of its inhabitants in general and girls and women in particular. Members asked whether OSA has a partner for collaboration and who will manage it. This project will be implemented in collaboration with CUTM (Centurion University) Paralakhemundi Campus. There is commitment for funds which is outside of OSA core fund and it is \$4K per year for next 2 years. The BOG members were requested to go through the proposal and later approve the updated proposal electronically.
2	OSA Higher Education Meeting in Odisha	 Utkal University has agreed to host the meeting on Dec 21st. A request to members will be sent to solicit their participation. Also 'OSA Public Library Open Forum; will be held during that time. The Education Committee will discuss and finalize the details. Plans to have similar event at FM University based on interest of members to participate in the meet. Dr. S.K.Dash asked if there is an Odia Department as he heard from some sources that there is no Odia Department at FM University. Odia MA and M.Phil degrees are offered by FM University but the courses are offered under another department. He suggested to discuss with VC if Odia Dept can be a separate department as the University bears late Fakir Mohan's name.
3	Boston 2016 Convention Update	 Arun: Ready to sign hotel and convention center contracts in next week or so. Hotels: There are 2 hotels OMNI hotel which is close to Convention Center is \$130 per night and other hotel is \$115 per night. Convention Center with Buyout for outside food will cost \$110K for 1000 people. Convention Team is planning to have tiered registration starting with \$135 for early bird and \$200 on-site. Members suggested to keep the registration and other costs lower. OSA Officials also said they have discussed the issue with Convention team and because of the geography and very strong labor laws the convention team is having challenges with the cost structure. Convention Team was advised to share the budget for the convention. Sushant Satpathy solicited input from members regarding OSA Fee for Student attendees.



		There is a request from Convention team to waive it for students and EC has a favorable view for this suggestion. It was decided to send the proposal for electronic approval.
4	OSA Member Directory Change	Siddharth Behera updated on OSA Member Directory change and it will be rolled out to members after it is rolled out to BOG members. BOG members should inform if they find any issue.
		Sushant: New OSA directory is important for us. Our plan is to tie this with convention registration. Also, we need updated directory for eVoting. Once we have this directory system we should be able to maintain non-member records and print it as part of OSA directory.
5	2015 Convention Closeout Process	Siddharth informed that he has sent out a note to 2015 Convention team for closeout process and have suggested convention should make all payments in advance so they are cleared including Indian Bank account payments before Nov 30 th .
		There is no intimation regarding Audit Team and if the past EC has not established one then current EC has to appoint one.
		EC informed that although it is a requirement per OSA Convention Guideline that Convention should use Accounting Software like Quicken/Quick Books, 2015 Convention has decided not to do that.
6	Past Convention Music for	Past Convention Music should be collected for OSA Archive.
	OSA Archive	This is a requirement per OSA Convention Guideline.
7	Round Table	Sukant Panda informed about the successful KP by Ohio Chapter in Cleveland. In addition there were KP celebration by local Columbus and Cincinnati communities.
		Pramod Mahapatra informed that they had KP celebration.
		Arun Mohanty said they had KP celebration and more than 70 families joined. They discussed convention planning with everyone present and the convention team was announced.
		Michigan also had KP celebration with 50-60 families. Sushant said he had the pleasure of joining MI-OSA friends for their KP celebration. Thanked Pradipta Mishra and chapter for wonderful time.
