1	2015-2017 Executives	Tapan Padhi welcomed and congratulated 2015 executives and introduced them to BOG members.
2	Award announcement	Sikhanda Satpathy informed the names of the recipients of various awards that were given by award committee and asked BOG members for their opinions. BOG members unanimously agreed to the recommendation given by award committee.
3	Dr. S. K. Dash Foundation	Tapan Padhi thanked Dr. S.K.Dash Foundation for instituting a \$100k OSA fund from which OSA would receive \$10k every year.

4	Ohio membership fee collection issue	 Prashanta Ranabijuli reminded that "the proposal was approved by BOG members that the lost membership fee will be covered from the convention income. Convention 2014 generated a net profit of \$13,381.28. The lost revenue of \$2,520 (63x\$40) should be deducted from this profit. As a result, the adjusted profit would be \$10,861.28. This adjusted amount should then be divided equally (\$5,430.64 each) between OSA Chapter and OSA National." Anil Patnaik mentioned that the chapter members did not want to pay this back. He also mentioned that Ohio donors were asking to return their donation money. Jhara Das said donation money cannot be returned after issuing tax deductible donation receipt. Prashanta said that tax donation receipts have been issued to all donors. Anil said he cannot return the money to OSA as chapter members are not agreeing to it. Sabita asked him to forward the email communication to BOG members. He mentioned that it was verbal communication with his chapter members. BOG members discussed about the penalty if the chapter fail to meet the obligation. Tapan Padhi said the chapter should be banned and chapter president cannot participate in any voting. Sikhanda Satapathy pointed out that we can only do what the constitution says. As per constitution, 'Should the Host Chapter fail to meet its obligations under this Bylaw II, it shall not be permitted to host another Annual Convention for a period of ten (10) years'. Sitakantha Dash proposed to waive the penalty and send a warning to all the chapter presidents. Sabita Panigrahi seconded it. It was approved with majority.

5	2015 Convention committee proposal	Convener, Pratap Das stated that there was a severe cash flow problem and the cost of hosting a convention at this venue and such scale has become pretty high. Hosting of Global Odisha Conference and the Amazing Odisha performance in Kennedy center in addition to the OSA Convention has escalated the cost. Certain unfortunate events such as last minute visa issuance and delayed donations expected from India had put the convention in a very difficult financial situation. He requested OSA to provide \$25K grant from OSA's general fund as a contingency measure. Most BOG members felt that a grant shouldn't be provided. Many suggested that a loan should be considered to solve the immediate cash flow problem. The BOG wanted to learn more about convention finance and fund raising status. The convention treasurer, Bijay Dash and Convention fund-raising committee chair, Hemant Biswal were invited to provide the status. They provided the requested information and stated that a \$25K loan would greatly help the cash flow problem, and that if all pledges were made good and the cost did not escalate, the convention account would break even. Sikhanda Satapathy mentioned that eight local members had agreed to lend the convention \$40k to solve the immediate cash flow problem, and since Sitakantha Dash has provided \$15k donation on an urgent basis as a grand sponsor of the Kennedy Center event, a \$25k loan from OSA would obviate the need to take loan from individuals. Sitakantha Das proposed OSA to provide \$25K as a loan to the Washington DC chapter. It was seconded by Pramod Mahapatra, and was approved with majority. Siddharth Behera and Sunil Sabat voted against the proposal and Prashanta Ranabijuli abstained.
6	2016 Convention	Tapan Padhi thanked the Odisha Society of New England (OSNE) to come forward to host the 2016 OSA convention in Boston area. Chapter president Arun Mohanty invited everyone and requested to encourage their local members to attend 2016 convention.
