### 3. Secretary Report

Secretary Sabita Panigrahi informed that the BOG meeting minutes have been regularly published in OSA Website, OSA newsletters and in OSAnet.

Last year's GBM minutes (2014) were presented. The motion was forwarded by Uma Ballav Mishra and seconded by Gopa Patnaik for the approval of last year's GBM minutes. It was approved unanimously.

#### 4. Treasure's Report

Treasurer Prashanta Ranabijuli reported the 2014 Convention account and 2014-2015 OSA Account Summary report. The report was distributed in OSAnet for the members to review.

He reported that OSA's finance increased year over year. Total Balance as of 05/31/2015 \$239,474.35 Total Balance as of 06/01/2014 \$220,923.52

#### Net Increase \$18,550.83

OSA's balance increased by more than \$32K after the transition Total Balance as of 05/31/2015 \$239,474.35 Total Balance as of 09/01/2013 \$206,726.58

#### Net Increase \$32,747.77

He shared the 2014 convention report. Total Convention Income: \$194,431.19 \* Total Convention Expenses: \$181,049.91 \*\* Net Income: \$13,381.28 Adjusted Income: \$10,861.28 \*\*\* \* Includes OSA Fee of \$4,140, membership fee of \$3,100 and loan of \$10K from OSA \*\* Includes return of the above fees to OSA \*\*\* Adjustment of the lost membership fee of \$2,520 (63 non-members) from the profit, as approved in the BOG meeting.

Prashanta also shared the achievements in the past 2 years.

- OSA's Long-term investment is performing well Gain of about \$6K in 7 months. Expected to generate upwards of \$75K in 10 years.
- Establishment of ERF(Emergency Relief Fund) and Annual Fundraising drive

About \$16K in this fund currently for future humanitarian needs. Prior to ERF we had raised and disbursed about \$100K in several fundraising drives.

- Improved income sources Effort to increase the source of income
  - OSA Fee increase from \$15 to \$25
  - Long-term investment
  - AmazonSmile program participation
- PAN Card for OSA has been obtained
  - PAN card is now a necessity for receiving funds in India
- OSA's India Bank Account is opened Potential for getting additional sponsorship money for OSA
- Quarterly Account Statements are promptly shared on OSANet
- Receipts are issued for donation and membership fee collection

Durga Mishra proposed to accept the treasurer's report and Surya Mishra seconded.

Sushant Satpathy had a suggestion that each specific fund should be used for specific fund.

Uma Mishra asked questions about distributing souvenirs to all the members. Sikhanda Satpathy explained the reason pointing to the constitution.

JayGopal Mohanty asked to know more about OSA fee. Sikhanda Satpathy explained OSA fee and its usage.

Debaki Choudhury suggested about complied donation receipt.

Tapan Padhi explained the donation money disbursement as question was asked by Pramod Mohanty.

The finance report was approved unanimously.

### 5. Constitution amendments

Vice President Sikhanda Satpathy presented two amendments. He mentioned that the motions were sent on 4<sup>th</sup> of June, 2015, prior to GBM. After receiving feedback, they were updated and were being presented at the GBM.

### Motion 1: Bylaw II Section 3

Rationale for Motion 1:

The convention ends the first week of July.

The OSA Secretary and Treasurer are expected to prepare and submit the list of voting members to the election committee by December 31 of the same year.

However, as per bylaw II, section-3, the host chapter President should submit the Treasurer and the Convention Audit Committee within six(6) months after conclusion of the Annual Convention which is falling after December 31 i.e. January first week of the following year.

The discrepancy between these two submission dates needs to be amended.

#### Current Bylaw II, Section-3:

"...It is the responsibility of the Host Chapter President to summarize any collections and expenses relating to the Annual Convention, and prepare a written list of any new members to have joined OSA during registration for the Annual Convention, and submit the same to the Treasurer and the Convention Audit Committee within six (6) months after conclusion of the Annual Convention." **Current** Bylaw IV, Section-4:

"...It is the joint responsibility of the Secretary and Treasurer to prepare a list of Voting Members, as described in these Bylaws and the Statement of Rights, by December 31st of the year preceding an election year for submission to the Chairperson of the Election Committee."

#### **Proposed modification:**

#### (Replace 6 months with November 30 in By-law II, Section 3)

**Resolved that** it is the responsibility of the host chapter president and convenor to summarize any collections and expenses relating to the Annual Convention, and prepare a written list of any new members to have joined OSA during registration for the Annual Convention, and submit the same to the Treasurer and the Convention Audit Committee within six (6) by November 30 of that year months after conclusion of the Annual Convention."

Sikhanda Satpathy brought the motion which was seconded by Uma Ballav Mishra. After discussion, it was passed with simple majority.

Motion 2 - Bylaw VIII

#### **Rationale for Motion 2**

A proposal to BOG members through email is assumed to have received a "yes" vote if no response is received within 2 weeks of submission of the proposal.

Many BOG members, especially new members, may not be aware of this clause, and reminders citing this clause would ensure an active decision to vote "yes" by not responding.

## **Current Bylaw VIII Voting rules**

Approval from the Governing Board shall be sought via electronic mail. In the event a member of the Governing Board does not respond within two (2) weeks after a request for approval has been circulated to the Governing Board, it shall be assumed that the Governing Board member has approved the request.

# Proposed modification to Bylaw VIII Voting rules:

# **Resolved** that

Approval from the Governing Board shall be sought via electronic mail. In the event a member of the Governing Board does not respond within two (2) weeks after a request for approval has been circulated to the Governing Board, and at least two reminders (including, but not limited to, those sent 7 and 10 days after the initial request) to vote citing this clause are sent to the member, it shall be assumed that the Governing Board member has approved the request.

Sikhanda brought the motion and it was seconded by Gagan Panigrahi. It was approved with simple majority.
