Update By President	President, Lalatendu Mohanty, summarized the Membership action report which was shared with BOG members. He mentioned that there were two categories of recommendation by the committee a) Membership Restructure b) OSA Branding & Image Transformation	
	He also emphasized on work needs to be done to attract more members by building a stronger OSA profile collecting last 10 years work of OSA	
	He also want the BOG to consider in building support groups for members and non-members. As the first stage, he wants big chapters to take initiative to form a) Indian Consumer Help Group b) Women's Support group	
	 He also updated that OSA Impact grant of \$4k was disbursed to KrushCo – a single-window platform for farmers to obtain inputs, technical supports and selling their outputs. Earlier plan of granting it to clean water supply had some issues and therefore, the grant was withdrawn. This was an OSA NE Youth initiative and a eKutir collaboration. 	
Update By Vice President	 VP, Susil Panda, updated the status of 50th Convention Selection Committee. The committee is meeting with all three aspirants and will advise their finding by end of this month for BOG to vote. 	
	 He also stated the Convention Guest selection committee have met and they will soon finalize the chief guest selection. 	
	 The award committee team will be finalized in a day or two and they will work on OSA National Awards soon. 	
Update By Secretary	 Secretary, Amar Senapati, requested BOG members to look at the chapter elections and update any changes. 	
	 He also informed the BOG that 2018 Convention Team is in process of printing the directory. All members will be getting "Address Verification" emails with their address as in OSA records for confirmation. He also encourages the members to pass on the messages through local chapter email group.

Membership Action Committee recommendation	 Lalatendu Mohanty stated that OSA membership is sluggish and a drastic measure is needed to attract new members. He recommended the following – BOG to vote on - Reduce Membership rate \$200 Until 2018 Convention. Bring it to 2018 GBM for permanent reduction Reduce Student Membership to \$0 for full time students IPP, Sushanta Satpathy had constitutional concern about any reduction in membership fee. He also agreed that similar reduction happened in last five years, after the new constitution took into effect. Lalatendu agreed to revisit the constitution and submit the temporary membership reduction proposal directly to BOG via email at a later time BOG Members discussed about the pros & cons of new membership category "Non-Voting Member" recommended by the Membership Action Committee BOG Members requested additional information from the Membership Action Team and would like to talk to them, if it can be arranged. Here are some clarification they would like to have for further discussion - Rights of NVM (ie. Handling local finances, nominating members for elective positions, voting in GBM etc.) Request to identify the changes needed to constitution to accommodate NVM
