	Option 1 – OSA as an Interested Party (OSA will receive (unverified) information and reports from MoSchool and share in OSA's forums with Disclaimer of no liability to OSA and direction to members to conduct their own due diligence before making contributions)
	Option 2 - Partnership (without MOU) (OSA will collaborate with MoSchool leadership on the program and roadmap with a need of Financial Transparency and Program roadmap with milestones)
	Option 3 - Partnership (with MOU) (Option 2 + OSA will collect donations from members through its own bank and transfer the funds to MoSchool with purpose for each donation)
	 At this OSA agrees to Option 1 and may opt for other option is Mo School Leadership agrees to OSA's requirement
	- The OSA Cultural promotion initiative is restructured. There will be three tiers and also an option to provide a refundable seed money up to \$1000 for small chapter needing a helping hand.
