| President Update | President Lalatendu Mohanty started the meeting with thanking all of the BOG members for attending the session. He updated and requested on the below listed discussion points. |
| | ERF : The ERF fund approved and released for the family of Mr Kohinoor Banerjee was cleared and paid by OSA. The BOG approved amount was \$1800. |
| | He also updated on the ERF request for Pragyan Anshuman Pradhan and thanked the BOG members for approving the fund (\$570) for covering the funeral expenses. He requested secretary to record the BOG approvals as the meeting minute. Please refer the appendix of this meeting minutes for the BOG approval details. |
| | As per the current guidelines OSA can release up to 7K per event. He brought up and discussed on how to generate fund for ERF. There are few ideas were discussed by Kuku Das, Deepak Sahoo and Tarini Dash. I.e. Generate money independently for ERF, Direct portion of the membership and registration fee generated from every convention etc. It was also discussed to decide on a lower limit for ERF so that if the fund goes below the lower limit then the OSA management needs to generate more fund. At least 14K to cover two events. Nothing was decided but all agreed that this needs to be discussed in detail. |
| | MNM: He updated the BOG on the latest progress and movement of MNM. The MOU is already signed by Govt of Odisha. OSA now needs to play a partnership role both with funding and logistics. Attaching the details of "MNM & OSA" for reference. |
| | OSA Impact: President also updated on the OSA Impact initiative status. He said OSANE is waiting on the request from the OSA Impact team to release the \$800 fund to Sikhya Organization. |

CONCEPT NOTE FOR OSA Collaborating to Support Malaria Elimination in Odisha State Background

In 2011, India defied all odds to defeat polio by rallying an entire country to the cause. Stakeholders from all sectors came together to achieve the "impossible," reaching 172 million children and driving out any last vestige of the



disease in the country. With polio elimination achieved, Prime Minister Modi is now setting India's sights on ridding India of another killer disease: malaria.

Malaria is a leading cause of school and work absenteeism and places a disproportionate burden on health systems. India's success in achieving malaria elimination is critical to improving the lives of the country's most vulnerable people, especially women and children.

The Challenge in Odisha State

Between 2016-2017, India marked a 24% decline in malaria cases with the eastern Indian state of Odisha leading the way. Prior to those reductions, Odisha constituted more than 40 percent of the entire malaria burden in India. In many ways, Odisha is a microcosm of the malaria challenge across India: thirteen of the thirty districts in the state have an annual parasite index of greater than ten, placing them among the highest-burden areas in all of India. Meanwhile, eight districts have an API of less than one, which means they're slated to eliminate by the end of 2020. Odisha's leadership in addressing malaria successfully in both high-and low-burden settings could hold lessons for the rest of India to follow.

The state has seen recent success in driving down malaria cases in the highest-burden districts by 80 percent from December 2016 to December 2017 through a series of investments and innovative programming. Odisha dramatically scaled up efforts to diagnose and treat malaria through its signature DAMaN initiative, which stands for Durgama Anchalare Malaria Nirakaran, or "Malaria Control in Inaccessible Areas." The program focuses upon village-wide testing and treating campaigns (along with malnutrition and other services) to substantially reduce parasite levels before the monsoon season causes mosquito populate ions (and malaria) to spike. Malaria No More is now working with the state to build on recent successes, ensuring gains are documented, scaled, and sustained so that Odisha can achieve its 2027 elimination target.

Malaria No More India and OSA

In 2016, Malaria No More began evaluating the opportunities and challenges in India by conducting a comprehensive technical, advocacy, and communications landscaping with the Clinton Health Access Initiative and support from the Bill & Melinda Gates Foundation. Based on this analysis, MNM has established an ambitious program to mobilize political will and provide India the technical "surge capacity" to adopt new strategies and technologies required to eliminate malaria in the next 10 years.

In 2019, MNM and OSA formally launched a partnership to create a network of OSA campaigns to support MNM's Odisha program to eliminate malaria by 2030. The Odisha Society of the Americas (OSA) is working with Malaria No More to drive awareness about the



burden of malaria in Odisha and help to engage with key individual and institutional stakeholders, both in Odisha and the U.S., to support and resource the Odisha program.

As Malaria No More looks ahead, we've begun to outline just three of the transformational ways OSA can help MNM's Odisha program in 2019:

SEED FUNDING INVESTMENT

Malaria No More India is at a pivotal moment – with opportunities for programmatic scale-up, but not all of the necessary resources secured in order properly pursue. Malaria No More requests financial support at the combined level of \$50,000.00 from The Odisha Society of Americas' Leadership and Committee Members to help build momentum and work as a motivator as we work towards finalizing the Malaria Action Committee and shape our partnership with OSA members ahead of the OSA 50th Convention this July. **Financial support would:**

• • Provide MNM India team with proper office equipment, computer hardware, and additional HR costs to help kick start operations in country

• • Provide support for Odisha hiring process to capitalize on the growing opportunities with outside partners and Government officials for malaria elimination
